## Background to **Kensal Rise NW10** farmers' market survey

#### **Summary:**

• 95% of business owners and 94% of residents surveyed are in favour of a farmers' market in the Station Terrace area. Examples of established farmers' markets, and in very close proximity to rail stations, include West Hampstead and Kew Gardens markets.


#### **Background:**

- This document presents:-
  - Results from a survey of Kensal Rise local business;
  - Results from a survey of local Queen's Park business located in very close proximity to Queen's Park farmers' market. The business were asked whether the market was having a positive, negative or neutral impact on their business;
  - Results from a snapshot survey of Kensal Rise residents regarding their appetite for a farmers' market in Kensal Rise; and
  - Factors to consider in respect of establishing a farmers' market in Kensal Rise.



- The main business district of Kensal Rise businesses is spread over 0.22 miles of Chamberlayne Road, between Leigh Gardens and Mortimer Road.
- For this survey, 74 Kensal Rise businesses lay within this business district, and within a 0.2 mile radius to the Station Terrace area. This scope coincides with the area coverage for the Kensal Rise Residents Association (KRRA).
- Businesses outside this 0.2 mile radius were excluded from this survey, as they are located a fair distance from the Station Terrace area, and therefore not deemed visible enough to attract competition from a potential market.
- Views of 63 business owners / managers collated with the remaining 11 uncollated, as the owner / manager was not physically present to partake in the survey.


### Structure of the Survey (Kensal Rise NW10 Business)

- Kensal Rise business owners and managers were visited and spoken to in person between 20<sup>th</sup> and 31<sup>st</sup> March 2019.
- Business owners were asked to indicate by putting their name to the survey and signing whether they would be in support or against this proposed farmers' market.
- In addition, business owners were asked to consider whether they felt a farmers' market would pose as a competitive threat to their existing business and product offering.

#### **Station Terrace Businesses**



- Vibrancy in area, strengthening community ties and engagement.




# Some anecdotal comments from local Kensal Rise NW10 business owners



## Overview of **Queen's Park NW6** Sunday farmers' market

- The market has now been in operation for 11 years, and is operated by London Farmers' Market. During that time, two new supermarkets have opened on Salusbury Road (Marks and Spencer, and now a Coop).
- The charts opposite show there are a variety of reasons that attract visitors to the market, with good quality food being a main draw.

## Background to Queen's Park NW6 business survey

- On 24 March 2019, a physical inspection was made of the business district area in Queen's Park, this starting at 11am and ending at 2.30pm. The timing of this visit was deliberately chosen, as this is that time that the farmers' market would be in operation, thereby presenting an opportunity to observe first hand activity taking place in and around local business outlets, especially those in close proximity of the farmers' market, and offering similar product offerings to those sold in the market.
- The express purpose of this visit was to speak in person with local business to establish whether the farmers' market had had either a Positive, Negative or Neutral impact on their business.

## Background to Queen's Park NW6 business survey

- 17 business owners / managers were spoken to in person. Whilst there are more than 17 businesses along Salusbury Road, they were closed. Nevertheless, the nature of the business closed on Sundays comprises activities which are largely non-food or drink related: Glass Cutting and Framing; Nails; Post Office; Estate Agent; Pharmacy.
- The product offerings of the above businesses surveyed ranged from food outlets such as restaurants, coffee shops, cafes, delicatessens, pubs and a bakery selling pastries, cakes, hot beverages, cooked breakfasts, cheese, wine, etc. Other businesses sold flowers, clothes, newspapers, magazines, pharmaceuticals etc.

• Physical and visual inspections indicate that local Queen's Park businesses have not been negatively impacted by farmers' market.

 Reported benefits of market - increased footfall, vibrancy injected into local area and economy, excellent meeting point for community.








What would be involved in setting up a farmers' market in **Kensal Rise NW10?** 

London Farmers' Market who operate Queen's Park Sunday market, have offered the following comments on points to consider for a Kensal Rise market:

- Refurbished (Kensal Corridor works, not additional works) uncluttered open space next to the stationfree from street furniture and with bike parking around the edges so as not to take up stall space;
- A surface strong enough to take vehicle activity to avoid cracked paving;
- Servicing / loading access from the kerbside free from Bus Stands;
- Power and Water for traders;
- Planning permission and an agreement / licence fee with Brent Council for using the space; and
- Market Management provided by operator, during market set up and trading hours, including waste removal and marketing for the event. In addition, stalls vetted and production premises inspected.
- Parking For a Saturday market:
  - 50-60% of stalls would deliver and go on to other London markets;
  - 5-10 park on single yellow lines or parking bays not controlled on Saturdays.

At Queens Park, a small number of vans park on site and around 10 vans park on the street in the local area.
