A Festive Season in Queen's Park Ward

In the lead-up to Christmas, we hope many residents were able to enjoy — or at least catch a glimpse of — some of the wonderful festive events taking place across the Queen's Park Ward.

Out-of-Service Buses: Ongoing Pressure

KRRA continues to challenge the heavy impact of out-of-service diesel buses on Chamberlayne Road and Station Terrace.

While residents in Liddell Gardens have seen some relief following sustained local campaigning, Chamberlayne Road remains under intense pressure. Displaced traffic from surrounding roads has brought bus services to a standstill at peak times, compounding noise, vibration and air pollution for residents and businesses.

We have formally urged Brent Highways and TfL to introduce targeted solutions, including bus gates and smarter traffic signal phasing. This remains a priority issue for KRRA.

Experimental Traffic Orders: KRRA Position

The Kensal Rise Residents Association (KRRA) continues to challenge the Experimental Traffic Orders (ETOs) introduced across several Avenues in the Queen's Park Ward.

While KRRA is not opposed to traffic management in principle, extensive community engagement shows strong opposition to the current approach. Evidence indicates the ETOs have not reduced traffic overall, but instead displaced it onto surrounding roads — particularly Chamberlayne Road.

Chamberlayne Road is a C-classified road, intended for local traffic, yet it is now used daily as a cut-through from nearby motorways. Between 2020 and 2022, there were over 40 recorded collisions on Chamberlayne Road, making it the most dangerous road in the Queen's Park Ward. This has been further exacerbated by the narrowing of the road at its southern end, introduced against KRRA advice, increasing risks for pedestrians and cyclists.

A first petition opposing the ETOs attracted over 1,400 signatures, followed by a second petition submitted on 17 November 2025 with 1,241 signatures. Together, these demonstrate that opposition to the current ETOs remains high across the ward.

KRRA continues to call on Brent Highways and local councillors to give Chamberlayne Road the long-overdue attention it deserves, and to stop treating it as a strategic through-route when it is neither designed nor classified for that role.

Kensal Gasworks: KRRA Objection Submitted

KRRA has submitted a formal objection to the proposed redevelopment of the Kensal Gasworks site at Ladbroke Grove.

The scheme proposes nearly 900 homes across towers of up to 31 storeys — a scale that is entirely out of character with the surrounding 4-6 storey neighbourhood. Our objection highlights serious concerns around traffic and highways capacity, air quality, public health, lack of schools and healthcare provision, and harm to nearby heritage assets including the Grand Union Canal Conservation Area and Kensal Green Cemetery.

While we recognise the need for new housing, this proposal represents overdevelopment without the infrastructure to support it. KRRA has urged the Council to refuse the application.

Cleaner Air and More Trees for Kensal Rise

KRRA has responded to Brent Council's Draft Tree Strategy, welcoming its ambition while highlighting serious gaps affecting Kensal Rise.

Our submission calls attention to some of the borough's worst air quality hotspots including Chamberlayne Road, Station Terrace and Ark Franklin Primary Academy — and urges Brent to designate Kensal Rise as a Priority Air Quality Canopy Zone, with targeted tree planting, traffic management and improved monitoring to protect residents' health.

Community Safety & Policing

KRRA recently responded to a local policing consultation, reflecting growing concerns from residents about safety in our neighbourhood. We have been particularly troubled to hear parents speak about incidents involving their children, including muggings, alongside ongoing issues such as antisocial behaviour and motor theft. This is not acceptable, and residents deserve to feel safe in their own streets.

KRRA feeds directly into the Brent Safer Neighbourhood Policing Panel and helps shape ward policing priorities, ensuring residents' experiences and concerns are heard by the police. We continue to raise issues affecting Kensal Rise and the wider Queen's Park Ward, pressing for visible policing and effective responses.

Where a resident is unfortunately a victim of crime, it is vital that incidents are reported. No crime is too small to report — doing so helps the police build intelligence, identify emerging hotspots, and direct resources where they are most needed.

Your Safer Neighbourhoods Team is part of the Metropolitan Police and is dedicated to serving your local ward. The team works closely with the council, community leaders and residents to agree local policing priorities and find long-term solutions to neighbourhood problems, while maintaining a wider focus on reducing crime across London.
